(a)	<u>Vice-Captain</u> – TT had advised PP that he was finding it difficult to attend Thursday meeting due to work commitments. A more suitable day for him (TT) would be a Monday. The Committee decided to leave the meetings on a Thursday due to other members finding it difficult on a Monday. PP – As a consequence of the recent Past Captains meeting, the Vice-Captain had been given 3 suggested names by the President of members who were willing to stand for election as Club Vice-Captain.	
(b)	<u>Colour of Tees</u> – PP said that one of the greenstaff had mentioned the problem of visitors playing-off the yellow tees. Some clubs used the yellow as there competition tees (our blue). The Committee agreed that the Pro Shop should advise all visitors as to the playing tee.	
1023	MANAGEMENT COMMITTEE	
	MC said that as the Manco meeting was held last night (16 May 2016) abridged minutes had not been distributed. He would however highlight the important points.	

	<p>(a) <u>Ladies admin grant letter from the Ladies Captain:</u> The Committee agreed that while there were more members, certain aspects of the admin work done by the Ladies had decreased and were now being done by the club employees. The additional increase of £50 had therefore not been granted.</p> <p>PM said that she was surprised and also disappointed in the Manco decision. Why did the Ladies Section have to justify the grant when other sections did not have to justify. MC said that no other section received a grant. PM said that she would inform her Committee.</p> <p>(b) <u>Jordan Howlett:</u> Jordan Howlett was busy with his final examinations to become a PGA Professional. Manco agreed that once he has passed he would be allowed courtesy of the course on the proviso that his name was associated / linked to KHGC whilst on the pro tour.</p> <p>(c) <u>Combined Committee Structure</u> MC said that he wanted to “test the water” and asked that the members consider a single committee structure at the club. The Captain, Ladies Captain and Seniors Captain together with the current Directors would form a new Committee. All members on the new Committee would be Directors. The Committee agreed in principle that he should proceed with the proposal.</p> <p>MC said that he would discuss the detail with RB and an outline document would be tabled at the next meeting for discussion.</p> <p>(d) <u>Revised Policy Rule 6</u> A member may apply in writing to the Club Manager to <u>suspend their membership due to serious ill health, injury etc.</u></p> <p><i>Ideally such a request should be supported by the production of a Consultants/Doctor’s letter stating that he/she is / was unfit to play golf and</i></p> <ul style="list-style-type: none"> ➤ the effective date of transfer (application date) to be utilised is, either the earlier date of that reflected on the Doctors / Consultants letter or the date that the letter or email was received from the member by the office. • the accrual subscription credit refund will be as follows: <ul style="list-style-type: none"> ○ 50% of the subscriptions paid for each full month calculated from the application date to the return date. • the accrual subscription credit refund calculated above, will be credited against the following years annual subscription. <p>here the doctors / consultants letter does not contain a ‘fit to play again’ date then the date used as the ‘fit to play again’ date will be as that agreed between the Club Manager and the member, or as approved by the Management Committee</p>
