County Competitions

Congratulations to Paul Dawson and Richard Clift who, after winning the handicap trophy last year, won the Dorset County Golf Union Inter-Club Scratch Foursomes Trophy after it was played over the course on 14 September. Almost there also were Peter Keeping and Bill Kennedy who were runners-up in the handicap event.

Mixed Foursomes Open

This was held on Sunday 11 August and run most successfully by our lady members. My thanks to them for lightening the competition load.

Order of Merit

The October Medals saw the end of points for this trophy and congratulations are in order for Graham Taylor. Consistency throughout the summer and steady form in the Championship helped him fight off any challenge.

Next month is November and we will already be into the opening rounds of the Winter Fourball with the Turkey Trot to look forward to and the prospect of Winter Golf. For the months of December, January and February the monthly medals will be run as stableford competitions. It is hoped this will speed up play whilst still providing a competitive round with handicap adjustments both up and down. The playing of the February medal as a Stableford will mean the moving of the President's Salver Qualifier to the March Medals.

Another big change for 1997 will be the Club Championship, Godfrey Elliott Bowl and 1st Captains Cup. These are 36 hole competitions and will be played as one event over two Sundays. The Championship will remain a scratch event and the Elliott Bowl will be limited to 14 handicap whilst the winner of the 1st Captains Cup will come from the 15-24 handicap range. Competitors will be able to choose their own start time for the two days and a special slot will be reserved to low handicaps at the start of the afternoon session.

## GREENS NEWS

A policy has been adopted by the greens committee to carry out essential improvements and maintenance to the tees and surrounding areas, during the winter. Some tees will be enlarged to allow continuous play throughout the year and others will be generally maintained.

Work will continue on and around the 11th tea to include planting more cypress trees and the upgrading of the right hand tee for the ladies' use.

The 13th ladies' tee has now been permanently moved to the top area and the yellow marker is now on the lower tee. Members playing off the yellow markers may use the white tee on this hole if they so wish.

The work on laying the new stepped path to the 6th tee is now in progress and will be a vast improvement.

The relaying of the 8th green has been shelved for twelve months to see how the surface of the new 5th green stands up to all weather play.

A tree programme has been produced by the Captain and Head Greenkeeper. This paper will be carefully screened and the course surveyed before any decisions are made. Tree maintenance is essential to encourage specimen trees to mature, maintain heather and encourage growth to trees, greens and fairways. This would involve pruning, thinning and the removal of some trees.

The old bunker to the right of the 5th fairway is to be re-

instated and other bunkers are planned.

Some sturdy seats are to be sited at various points around the course.

The vandalised drinking fountain has now been repaired after a long wait for replacement parts. Apologies for the delay.

Finally, thank you to everyone on the greens committee, who have given up a lot of their free time to help ensure that we have a course to be proud of. Once again, Derek Cheetham and his staff must be congratulated for maintaining a course that is the envy of many other golf clubs, near and far.

## NOTICE OF INTENT

FUTURE MANAGEMENT OF KNIGHTON HEATH GOLF CLUB

For the past two years the Management Committee has been considering the merits of adopting a two committee management structure in line with over half the golf clubs in Great Britain. The reasons are twofold. Firstly, under the present organisation the Captain bears the heavy responsibilities during his single year in office which detract from his ability to concentrate upon the golf and social activities which are central to his appointment.

Secondly, the management of a modern golf club has become a complex and demanding business calling for a more professional approach. Greater continuity in the handling of policy, financial matters, administration and the management of the course itself is required to ensure the prosperity of the club.

After careful consideration and review it has been decided to propose the adoption of a two committee structure comprising a Captain's Committee and Management Committee. The Captain's Committee would be responsible for all the golfing and social activities of the Club and be the guardian of its standards, tone and atmosphere. The Management Committee, in support of the Captain's Committee, would be responsible for all policy and financial matters, together with the attendant administration of the clubhouse, the course and the employees of the Club.

No requirement to change the Articles of Association of the Club is anticipated. The rules of the Club would require some amendment although much of this would be of the editorial nature. Rules 5,6,9,14,15,20 and 38 are all likely to be affected, and the opportunity re revise any ambiguous Rules should also be taken since the last revision was published in November 1994.

Any change to the Club Articles or Rules must be referred to Members for approval at a General Meeting. The details of any change must be made available to the members before any such meeting affording them the requisite notice. It has therefore been decided to call an Extraordinary General Meeting early next year, probably in mid March, for the express purpose of putting the proposed management structure to the Members of the Club.

Members are encouraged to submit any views that they may have on the proposed structure by doing so in writing to the Club Manager.
