1. **Apologies for Absence:** Jane Paine, Wendy Hanford
2. **Minutes of the Previous Meeting** – These were agreed and would be signed by the Lady Vice Captain.

3. **Matters Arising –**

The Lady Captain had a wonderful Lady Captain's Day and thanked everyone who had provided food for the tent and had helped at the event.

LVC: had checked with Reunert that the Ladies in the diary are all Social Members.

Under AoB, LN:– Early payment for the deposit at the Captain's Away Day could not be made as the Ladies Section do not pay anything towards the Away Day.

End of May balance was £4,261.86. No figures have been supplied as it is the Clubs Financial year end. Expenses in June include: prizes, Coronation Foursomes entry, flowers for Sylvia and items for the Lady Captain's Day & Invitation Day £601.84 – reducing the balance to £3,760.02.

£248.60 is being carried forward to the AGM for trophies, this will increase with every competition we play this summer, plus the £1,000 left in our account. The Club has taken £1,248.60 from 1st July.

We no longer get any money from ladies competitions as the Club takes 30% and pays out 70% in prize money.

At the next Committee Meeting we need to discuss what projects we would like the £2,500 to be put towards. i.e. Ladies toilets and showers. **ACTION: SS**
