All Clubs should adhere to the EG framework provided for "Play Safe, Stay safe" golf .

These have been published to assist clubs in providing as safe an environment as they can.

Failure to follow this guidance may leave clubs open to enforcement action from local authorities and/or Police, or subject to disciplinary procedures from England Golf.

* Face coverings *must* be worn when entering the clubhouse, administration office, locker rooms & toilets.

* Face coverings may be removed only when seated in the lounge, 19th and dining room for the purpose of eating and drinking.

* Locker rooms will be open for storage of golf clubs in allocated personal lockers.

* Players should still arrive changed for play and refrain from showering or changing in locker rooms.

* Toilets and wash-hand basins in locker rooms may remain in use.

Please assist us in providing a safe clubhouse environment for all.
