### **Terms and Conditions**

1. Tee reservations will be made as agreed. However, please note that these must be strictly observed and failure to do so will mean priority on the tee will be lost.
2. We ask that all societies play in 3-balls when recording individual scores in order to maintain a good pace of play.
3. No shotgun starts or Texas Scrambles are allowed.
4. Numbers attending must be confirmed 7 days in advance. All societies will be charged the full agreed rate for the day based on this number. However, members not able to attend on the day will be given a voucher entitling them to a round of golf and a “special” from the specials menu board for use on another weekday.
5. Our dress code is enclosed. All society organisers must make sure that all society members are fully aware of our dress code policy. We would ask you to ensure full compliance in order to save any embarrassment on the day.
6. The following time restrictions apply to society bookings, Monday - Friday:
  - a. Not before 10:00
  - b. Not between 12:00 - 13:30 (BST) and 11:00 - 12:30 (GMT).
7. ***In order to confirm your booking we require a £50 deposit payable in advance*** to be returned with the booking form. Deposit is non-returnable if cancelling within 7 days of the booked date. However, if an alternative date is agreed the deposit will be transferred to the new date.
8. No trolleys to be allowed on the tees, behind the white lines around the greens or to be pulled through the heather.
9. All society members must clearly display their green fee ticket during their round.
10. For insurance reasons, all societies must pay in full in the office before playing.
